

INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The **LGU-Gabaldon**, through its Bids and Awards Committee (BAC), invites suppliers to apply for eligibility and if found eligible, to bid for the hereunder contract:

- Name of Contract : **Supply and Delivery of various items needed for supplemental feeding program for Day Care Children (ordering agreement)**
- Location : **Gabaldon, Nueva Ecija**
- Brief Description : **Supply and Delivery of various items needed for supplemental feeding program for Day Care Children (ordering agreement)**
- Approved Budget for the Contract (ABC): **Php 1,308,600.00**
- Contract Duration : This project shall be procured through an Ordering Agreement arrangement for a period of one hundred eighty (180) calendar days from the of work commences

Delivery of Goods is subject to the necessity by the End User (MSWD) for one or more of the items covered in the Ordering Agreement and the need to actually order the Goods. The LGU shall require the delivery of the item identified in the Order Agreement. List in such quantity or scope and at the fixed price for which it was awarded by executing a Delivery Order Contract in favor of the supplier/service provider to obligate the latter to deliver or perform according to the terms and conditions stated in the Ordering Agreement.

The **LGU-Gabaldon** now invites Bids for the above items. Delivery of the GOODS is required within the period specified above. Bidders should have completed within two (2) years from the date of submission and receipt of bids, with an amount of at least 50% of the contract similar to the Project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. The post-qualification of the lowest calculated bid shall be conducted.

Bids received in excess of the ABC shall be automatically rejected at Bid opening.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).

Bid Documents will be available only to prospective bidders upon payment of a non-refundable amount of **FIVE THOUSAND PESOS ONLY (Php 5,000.00)** to the **LGU-Gabaldon** Cashier. Prospective bidders shall submit the Eligibility Requirements to the BAC at the same address.

The LGU-Gabaldon assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.
