RECALL OF DETAILED EMPLOYEE FROM ONE DEPARTMENT OR AGENCY TO ANOTHER

WHEREAS, pursuant to **M.C. No. 24 s. 2017 Section 13**, of the 2017 Omnibus Rules on Appointment and Other Human Resource Action; **b. Detail** – temporary movement of an employee from one department or agency to another which does not involve a reduction in rank, status or salary shall be governed by the following rules;

WHEREAS, on rule No. 2 stated that detail without consent shall be allowed only for the period of one (1) year;

WHEREAS, on rule No. 3 stated that detail with consent shall allowed for a maximum of three (3) years. The extension or renewal of the detail shall be discretionary on the part of the parent agency;

WHEREAS, on rule No. 4 stated that detail from one department or agency to another shall be covered by an agreement manifesting the arrangement between the agency heads that it shall not result in reduction in rank, status or salary of the employee, the duration of the detail, duties to be assigned to the employee and responsibilities of the parent agency and receiving agency;

NOW, THEREFORE I, ROLANDO S. BUE, Municipal Mayor of Gabaldon Nueva Ecija by virtue of powers vested in me by the constitutions, do hereby order that all employees that are detailed from one department or agency to another shall report back to its parent office.

This Executive Order shall take effect immediately.
