EXECUTIVE ORDER NO.3 s. 2014
CREATION OF SAGIP ILOG-DUPINGA TASK FORCE

WHEREAS, Dupinga River is the heart of the ancestral domain of indigenous peoples particularly the Dumagat Tribe. It is one of the most visited tourist destinations of the town because of its clean and cool natural stream water coming directly from Sierra Madre mountains;

WHEREAS, there are reports that the water shed of the river is being frequently invaded by some illegal loggers that operate the area.

WHEREAS, it is imperative to create the Sagip-Ilog Dupinga Task Force aiming in protecting the area to maintain its ecological balance;

NOW, THEREFORE I, ROLANDO S. BUE, Municipal Mayor of Gabaldon Nueva Ecija by virtue of powers vested in me by the constitutions and the laws do hereby order;

SECTION II. DUTIES AND FUNCTIONS. The Sagip-Ilog Dupinga Task Force shall have the following duties and functions;

1. Protect Dupinga River against all illegal activities concerning its ecological well-being;
2. Conduct regular monitoring activity in the area;
3. Report to proper authorities all illegal activities that may occur such as cutting of trees, charcoal making, and setting of forest fire;
4. Ensure that there are no parties engaged in any activity that may harm the area;
5. Apprehend the person involved in illegal activities and confiscate illegally cut logs and charcoals emanate in the area ;
6. Make and submit necessary report for every activity accomplished by the Task Force to Mayor's Office, MENRO and Police Station.

SECTION III. EFFECTIVITY. This Executive order shall take effect immediately upon approval.
