EXECUTIVE ORDER NO. 04 s.2014
REORGANIZING LOCAL ANTI-DRUG ABUSE COUNCIL

Whereas, the Department of Interior and Local Government Unit issued Memorandum Circular Nos.96-227, dated December 2, 1998, 99-226 dated December 21, 1999 and 2001-90, dated July 26, 2001, directing concerned government agencies to immediately reactivate, reorganize and strengthen, or cause the creation of their respective LADAC;

WHEREAS, there is an urgent need and imperative to reorganize the same, to update the composition of its members and this Local Government Unit previously adopted the above mentioned Memorandum Circular;

NOW, THEREFORE I, ROLANDO S. BUE, Municipal Mayor of Gabaldon Nueva Ecija by virtue of powers vested in me by the constitutions and the laws do hereby order;

Section I. That the **LOCAL ANTI-DRUG ABUSE COUNCIL (LADAC)** is hereby reorganized as follows;

SECTION II. **DUTIES AND FUNCTIONS.** That the LOCAL ANTI-DRUG ABUSE COUNCIL (LADAC) shall have the following duties and responsibilities;

1. Serve as focal point through which various organizations and individuals work together cooperatively in the planning, implementation and evaluation of programs on drug abuse prevention;
2. Provide for an effective mechanism for the coordination of existing services and programs and those which might be developed in the immediate future;
3. Provide for a mechanism to obtain funds, volunteer facilities and technical expertise;
4. Conduct information and education campaign on the ill-effect of illegal drugs, monitor and report to proper authorities, the drug pushers and drug users in this municipality;
5. Prepare a confidential watch list of drug users and pushers found in this locality, to be submitted to the PNP Anti-Illegal Drug Task Force for the latter's validation or verification leading to the arrest and filing of appropriate charges;
6. Perform other related responsibilities as may be assigned by competent authorities.

SECTION III. **COMPENSATION AND REMUNERATION.** The LOCAL ANTI-DRUG ABUSE COUNCIL (LADAC) shall perform their duties as such without additional compensation or remuneration.

SECTION IV. **MEETING.** The schedule of the meeting shall depend upon on the behest of the Chairman.

SECTION V. **EFFECTIVITY.** This Executive Order shall take effect immediately until further revoked or amended by the undersigned .
