EXECUTIVE ORDER NO. 05 s. 2014

REORGANIZING THE PROJECT MONITORING COMMITTEE (PMC) AND ITS SECRETARIAT

WHEREAS, Executive Order No. 376 s. 1989, as amended by Executive Order No.93 s. 1993, established the Regional Project Monitoring and Evaluation System (RPMES) to facilitate project implementation and devolve facilitation, problem solving, monitoring and evaluation of foreign, national and locally funded projects to the sub-national levels;

WHEREAS, as provided in the abovementioned EOs, Project Monitoring Committees (PMCs) originally established as the monitoring arm of the Local Development Council under Memorandum Order No.175, dated May 23, 1988 were tapped to operationalize the RPMES at the sub-regional level;

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum circular no.2004-78, dated June 22, 2004 and Regional Memorandum Circular No. 2011-12, dated August 03, 2011, enjoining to organize, reactive or reconstitute the local PMCs in their respective areas of jurisdiction;

NOW THEREFORE, I, HON. ROLANDO S.BUE, Municipal Mayor of Gabaldon Nueva Ecija, by virtue of the power vested in me by law, do hereby reorganized the **Project Monitoring Committee and its Secretariat** in accordance with Executive Order No.376, series of 1989, as amended by Executive Order No.93 dated June 1, 1993 as follows:

Section I. Composition. The Project Monitoring Committee (PMC) of this LGU shall be composed of the following:

Section 2. Scope of Monitoring. The scope of monitoring shall include all foreign and nationally-funded projects, including development projects funded from the Internal Revenue Allotment (IRA) share of Local Government Unit or supported by fund released directly to the municipal government and projects funded from local generated resources which are implemented within the territorial jurisdiction of this municipality.

Section 3. Meeting and Ocular Inspection. The Project Monitoring Committee (PMC) shall convene quarterly or in accordance with the behest of the chairman.

The PMC shall conduct regular ocular inspection of all projects as stated in Section 2, upon coordination with the implementing agencies or organizations and the secretariat shall prepare a necessary report to be submitted to the undersigned.

Section 4. Compensation and Remuneration. Members of this committee who are government officials and employees shall perform their duties as such without compensation or remuneration as provided under Republic Act No.7160, otherwise known as "The Local Government Code of 1991".

Section 5. Effectivity. This Executive Order shall take effect immediately.
