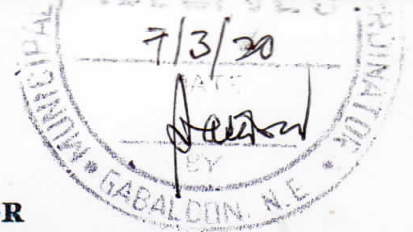

EXECUTIVE ORDER NO.2020-09
AN ORDER DESIGNATING OF MR.ROMEL R. DACUMOS AS GENDER
AND DEVELOPMENT (GAD) FOCAL PERSON IN THIS MUNICIPALITY OF
GABALDON,NUEVA ECIJA

WHEREAS: Executive Order No.08 enacted on June 1, 2020 created the Gender and Development(GAD) FOCAL Point.

WHEREAS, the GAD Focal Point in entrusted with the duty to establish GAD programs, projects and activities and other gender-related plans,

WHEREAS, GAD programs can be efficiently and effectively implemented through the designation of a capable person to personally coordinate, put into operation and execute such programs:

NOW THEREFORE, I, ATTY.JOBBY PETINES EMATA, Municipal Mayor of Gabaldon, Province of Nueva Ecija, by virtue of the powers vested in me by the existing and applicable laws do hereby order:

SECTION I. Appoint the Gender and Development (GAD) Focal Person-The Gender and Development (GAD) Focal Point shall have Focal Person who shall implement the GAD Programs, and Activities for this purpose; **MR.ROMEL R. DACUMOS** shall serve in the capacity.

SECTION 2.Duties and Responsibilities of the GAD Focal Person-GAD Focal Person:


- ~~1.Implement the GAD action Plan;~~
- 2.Catalyze, coordinate;provide direction, monitor and serve a technical adviser programs and project on women, gender and development concerns within the Municipality;
- 3.Advise and assist the GAD Focal Point and discharge its duties in between its meeting;
- 4.Unsure that all barangays shall prepare a GAD plan addressing gender issues of their locality following section 16 and 17 of the Local Government Code of 1991 and other related provisions;
- 5.Serve as Secretary to the GAD Focal Point, keeping and maintaining all its records and preparing necessary documents; and
- 6.Submit to the Mayor the three(3) months progress reports on the implementation of GAD Programs and an End Projects Reports(EPR) at the end of every activity. events or projects, together with in-depth liquidation of expenses.

SECTION 3. Separability Clause-If any provision of this Order or its application to any person or circumstance is held in valid, then the validity shall not affect other provision or application of their sub chapter which can be given effect without the invalid or application, and ~~to this end the provision of this Order as severable.~~

SECTION 4. Repeating Clause-All orders ,issuances rules and regulations or parts thereof, which are inconsistent with this Order are hereby revoked or modified accordingly.

SECTION 5. Effectively: This Executive Order shall take effect upon approval.
