**EXECUTIVE ORDER NO. 11 S. 2020**  
**CONSTITUTING THE EXECUTIVE COMMITTEE**  
**OF THE LOCAL DEVELOPMENT COUNCIL AND MUNICIPAL DISASTER RISK REDUCTION AND**  
**MANAGEMENT COUNCIL**

**WHEREAS**, it is hereby declared policy of the State that the territorial and political subdivisions of the State shall enjoy genuine and meaningful local autonomy to enable them to attain their fullest development as self-reliant communities and make them more effective partners in the attainment of national goals. Toward this end, the State shall provide for a more responsive and accountable local government structure instituted through a system of decentralization whereby local government units shall be given more powers, authority, responsibilities, and resources.

**WHEREAS**, pursuant to the principles embodied in Sec. 16 of the Republic Act 7160 states that Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, Section 111 of the same code explicitly expressed that an Executive Committee of the Local Development Council shall be created to represent it and act in its behalf when it is not in session;

**WHEREAS**, the Disaster Risk Reduction and Management Act of 2010 strengthens the Philippines' implementation of actions and measures for direction and mitigation in catastrophes. It is a very important step towards achievement of an enhanced response program for disaster risk reduction as well as, Section 15 of the said Act mandates the LDRRMC to take the lead in preparing for, responding to, and recovering from the effects of any disaster;

**WHEREAS**, it is deemed necessary that the Executive Committee of the Local Development Council and Municipal Disaster Risk Reduction and Management Council shall be created and its members shall establish policies that consistent with the policies of the National Government and then roll them out effectively across the municipality. The creation of Executive

of the two councils is tantamount in the observance of physical and social distancing during the conduct of a meeting that the National IATF set to avoid the spread of COVID-19;

**NOW, THEREFORE I, ATTY. JOBBY PETINES EMATA**, Local Chief Executive of Gabaldon Nueva Ecija by virtue of power vested in me by the constitution and Sec 444 of the Republic Act 7160 otherwise known as The Local Government Code of 1991 do hereby constitute the Executive Committee of the following:


