FOR Purchase and Delivery of CCTV Camera

The **LGU-GABALDON**, through the Budget for the contract approved by the respective Sanggunian intends to apply the sum of **Three Hundred Ten Thousand Pesos Only (P 310,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Purchase and Delivery of CCTV Camera** Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The **LGU-GABALDON** now invites bids for **Purchase and Delivery of CCTV Camera, specification, to wit:**

- **Third-party network cameras supported,**
 - **Up to 8 megapixels resolution recording**
 - **Support 1-ch HDMI, 1-ch VGA, HDMI at up to 4K (3840x2160) resolution.**

 - **up to 4 SATA interfaces**
 - **Support dual-os to ensure high reliability of system running**
 - **support various VCA detection alarm and VCA search**
 - **support H.265/ H.264/ MPEG4 video formats**
- 4 units: 4Mp EXIR WDR Bullet :0.01lux/F1.2, 4mm/F2.0 lens, DC12V & POE (802.3af), 120dbWDR, 3D DNR, EXIR range: up to 30m, IP66**
- 2 units: WD40PURX-78 Hard drive**
- 2 units: Gigabyte8Port Switch hub**
- 1 unit: Cat 6 Cable Wire Outdoor**
- 2 units: AirMAXac Sector 5.10-5.85GHz, 2x2 MIMO BaseStation Sector Antenna**
- 2 units: AirMAX 2x2 PtP Bridge Dish Antenna**
- 3 units: Fiber Optic Cable**
- 2 units: Multi Media Converter**

Delivery of the Goods is required **twenty (20) calendar days**. Bidders should have completed, within the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

3. Interested bidders may obtain further information from **LGU-GABALDON thru its BAC Secretariat** and inspect the Bidding Documents at the address given below during **8:00am to 5:00 pm**.
4. A complete set of Bidding Documents may be acquired by interested Bidders on **July 8, 2020** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **five hundred pesos only (Php 500.00)**


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The **LGU GABALDON** will hold a Pre-Bid Conference on *(not applicable)* at **SB Session Hall, Gabaldon Municipal Building, Gabaldon, Nueva Ecija**, which shall be open to prospective bidders.
6. Bids must be duly received by the BAC Secretariat at the address below on or before **July 16, 2020, 10:00am**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **July 16, 2020, 10:20am** at **SB Session Hall, Gabaldon Municipal Building, Gabaldon, Nueva Ecija**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The **LGU GABALDON** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
