

Invitation to Bid

(FY 2022 EARLY PROCUREMENT)

1. The **LGU Gabaldon**, is conducting this Procurement through early procurement activity (EPA) for FY 2022 to ensure the timely delivery of goods, implementation of infrastructure projects and rendition of consultancy services, consistent with the GPPB Resolution number 14-2019 dated July 17, 2019 where procuring entity (PE) is encouraged to start procurement activity short of award.

EPA shall refer to the conduct of procurement activities, from posting of the procurement opportunity, if required, until recommendations of the Bids and Awards Committee (BAC) to the HoPE as to the award of the contract, for goods to be delivered, infrastructure projects to be implemented and consulting services to be rendered in the following fiscal year (FY 2022), pending approval of their responding Sources.

The bidders, therefore, are herewith informed the following:

- a) Interested Bidders are invited/requested to submit their bid proposals based on indicative budget through this Invitation to Bid, together with the bidding documents;
 - b) The PE will evaluate the bid proposals and determine the winning bidder. The financial bid proposal of the winning bidder will be the contract price/amount which is considered fixed price. However, the Notice of Award (NOA) will only be issued upon the approval of the budget (short of Award)
 - c) Should there be a delay in the award as affected by the possible delay in the budget approval, the bid validity as specified in the bidding documents (which is maximum of 120 calendar days), the winning bidder may be requested to extend the bid validity accordingly (that is, changing the expiration of the original bid security). In case of the bidder's refusal to extend the bid validity, the bid submitted by said bidder will be rejected.
2. In this regard, The **LGU Gabaldon** through the **Budget for the contract approved by the respective Sanggunian for the calendar year 2022** intends to apply the sum of **Eight Million Eight Hundred Eighty Eight Thousand Pesos only (P 8,888,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction Projects, to wit;**

- Construction of Trading Post-Brgy. Bagting (Phase 2)
- Construction of Food Court – Public Market, Brgy South Poblacion
- Construction of Transport Terminal-Public Market Compound, Brgy. South Poblacion
- Construction of Multi-Purpose Building (Phase 2) Brgy. Bagong Sikat
- Construction of 2 units Green House-Municipal Nursery, Brgy. Pantoc
- Construction of Multi-Purpose Building-Brgy. Cuyapa

with **Project Identification Number 12172021-02**, Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

3. The **LGU GABALDON** now invites bids for the above Procurement Project under the early procurement activity. Completion of the Works is required for **Construction Projects, to wit;**
 - Construction of Trading Post-Brgy. Bagting (Phase 2) 90 days
 - Construction of Food Court – Public Market, Brgy South Poblacion 90 days


- Construction of Transport Terminal-Public Market Compound, Brgy. South Poblacion 90 days
- Construction of Multi-Purpose Building (Phase 2) Brgy. Bagong Sikat 90 days
- Construction of 2 units Green House-Municipal Nursery, Brgy. Pantoc 90 days
- Construction of Multi-Purpose Building-Brgy. Cuyapa 90 days

4. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
5. Prospective bidders may obtain further information from **LGU GABALDON BAC Secretariat** and inspect the Bidding Documents at the address given below from **Monday to Friday at 9:00 am to 5:00 pm**.
6. A complete set of Bidding Documents may be acquired by interested bidders on **December 20, 2021** from the given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos Only (P 10,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees and it will be presented in person.
7. The **LGU GABALDON BAC** will hold a Pre-Bid Conference on **“December 23, 2021, 10:00am”** at **Municipal Conference Hall, Municipal Building, Gabaldon, Nueva Ecija**, which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **January 5, 2022, 10:00 am**. Late bids shall not be accepted. Bidders requested to submit one (1) original and two (2) copies of their bids. Bidders are likewise requested to bring the originals of the documents submitted and present the same for comparison during the bid opening.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
10. Bid opening shall be on **January 5, 2022, 10:20 am** at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
11. The **LGU GABALDON** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
