1. **LGU-GABALDON**, through the Budget for the contract approved by the respective Sanggunian intends to apply the sum of **Six Million Pesos Only (P 6,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **PURCHASE OF MOTOR VEHICLE USE FOR PUBLIC TRANSPORT MODERNIZATION PROJECT, AS DESCRIBED BELOW:**

Specifications:

two (2) units, 4,009 cc Engine Displacement (Euro 4) 150 HP; 8,500 kg GVW; Diesel 4 cycle, vertical, 4 cylinders in-line, Turbo-Intercooler, overhead valve, water cooled, direct injection type, electronic control common rail type with catalytic converter; Approximately 7,250 mm total length; 6-speed, overdrive, synchromesh 1st – 6th; Leaf Spring Suspension; Folding Type Automatically operated (electric type) on middle; equipped with cabin doors; Passenger Seat: If without cab 24 passenger (perimeter seats) plus 1 passenger at front or If with cab 24 passenger (perimeter seats) plus 1 passenger at cabin; Fixed type, with sliding upper side window.

Accessories and Inclusions:

CCTV (recording only); Dash Cam and backing camera; Global Positioning System (GPS); Fire Extinguisher (5 lbs); Seat Upholstery – Leatherette.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **LGU-GABALDON** now invites bids for the above Procurement Project. Delivery of the Goods are **Sixty (60)** calendar days.

Bidders should have completed, within the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

- a. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

4. Interested bidders may obtain further information from **LGU-GABALDON thru its BAC Secretariat** and inspect the Bidding Documents at the address given below during **8:00am to 5:00 pm**

5. A complete set of Bidding Documents may be acquired by interested Bidders on **February 10, 2022** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **ten thousand pesos only (Php 10,000.00)**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **LGU GABALDON** will hold a Pre-Bid Conference on **February 16, 2022, 10:00am** at **Municipal Conference Hall, Gabaldon Municipal Building, Gabaldon, Nueva Ecija**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **February 28, 2022, 10:00am**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **February 28, 2022, 10:20am** at **Municipal Conference Hall, Gabaldon Municipal Building, Gabaldon, Nueva Ecija**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **LGU GABALDON** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
