

## Contract Agreement

THIS AGREEMENT made this 1<sup>st</sup> day of July, 2022 between **Municipal Government of Gabaldon, Nueva Ecija** represented by **Municipal Mayor Atty. Jobby P. Emata** (hereinafter called "the Entity") of the one part and **VRV ENTERPRISES AND GENERAL MERCHANDISE** of Centro Street, Brgy. Vega, Bongabon, Nueva Ecija, represented by **Nicolas Alabaso**, an authorized representative (hereinafter called "the Supplier") of the other part:


WHEREAS the Entity requested a quotation for certain **Purchase of Various Supplies and Equipment use in MDRRM Office** and has accepted a quotation from the Supplier for the supply of those goods in the sum of **SIX HUNDRED TWENTY-EIGHT THOUSAND ONE HUNDRED SIXTY PESOS ONLY (P 628,160.00)** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Bid Form and the Price Schedule submitted by the Supplier;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract; and
  - (f) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Bidder as hereinafter mentioned, the Bidder hereby covenants with the Entity to provide the equipment and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. The goods stipulated in this contract shall be delivered and ready for use not later than forty-five (45) calendar days in accordance with provisions of the Bid Documents


