

## Contract Agreement

THIS AGREEMENT made this 30<sup>th</sup> day of June, 2022 between **Municipality of Gabaldon**, Nueva Ecija of the Philippines, represented by **Atty. Jobby P. Emata**, Municipal Mayor (hereinafter called "**the Entity**") of the one part and **JONECO TECH MARKETING CORP** of #7, Pioneer St., cor., Sheridan St., Elena Roces Compound Highway Hills, Mandaluyong City, duly represented by **Mark Anthony A. Rubio**, authorized representative (hereinafter called "**the Supplier**") of the other part:

WHEREAS the Entity requested a proposal/quotation for certain **PURCHASE AND DELIVERY OF MONOBLOCK CHAIRS AND FOLDING TABLES USE IN LGU GABALDON** and has accepted a Bid from the Supplier for the supply of those goods in the sum of **TWO HUNDRED NINETY NINE THOUSAND PESOS ONLY (Php 299,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Bid Form and the Price Schedule submitted by the Supplier;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract; and
  - (f) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the equipment and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


