

Contract Agreement Form

THIS AGREEMENT made this 23rd day of August, 2022 between Municipal Government of Gabaldon, Nueva Ecija, represented by **Municipal Mayor Atty. Jobby P. Emata** (hereinafter called "the Entity") of the one part and **CHEMDIE ENTERPRISE** of Purok 5 Santo Rosario Old, Zaragosa, Nueva Ecija, represented by **Jeffrey D. Alberto**, Proprietor (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity requested a quotation for certain **Purchase of Sprayer and Insecticide use for dengue prevention and control** and has accepted a quotation by the Supplier for the supply of those goods in the sum **One Hundred Fifty Thousand Four Hundred Fifty Pesos Only (₱ 150,450.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) The Quotation Form and the Price Schedule submitted by the Supplier;
 - (b) The Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. The goods stipulated in this contract shall be delivered and ready for use not later than ten (10) calendar days in accordance with provisions of revised IRR RA No. 9184.
