This Contract Agreement has been made, by and between:

REPUBLIC OF THE PHILIPPINES, through the Municipal Government of Gabaldon, Province of Nueva Ecija with Office and postal address at **Gabaldon, Nueva Ecija** represented by the **Municipal Mayor Hon. JOBBY PETINES EMATA**, and hereinafter referred to as the "**MUNICIPALITY OF GABALDON**".

And

**NEECO II - AREA 2** a cooperative duly organized and existing under by virtue of the laws of the Philippines with office and postal address at Maharlika Highway, Brgy. Diversion, San Leonardo, Nueva Ecija herein represented by **RAMON M. DE VERA**, hereinafter referred to as the "**SUPPLIER**":

## WITNESSETH

**WHEREAS**, the **MUNICIPALITY OF GABALDON** upon the resolution of the Bids and Awards Committee (BAC) issued this contract agreement for the **Purchase and Installation of Transformer 37.5 kVA (materials & labor) intended for the Ligaya National High School to NEECO II - AREA 2;**

**WHEREAS**, **NEECO II - AREA 2** has submitted all documentary requirements to perfect this contract within TEN (10) calendar days;

**WHEREAS**, the Procuring Entity is desirous that the Supplier execute the Contract for the Purchase and Installation of 3-37.5kVA Transformer 3-phase (materials & labor) intended for the Multi-Purpose Building and the Procuring Entity has accepted the Bill Details for **FOUR HUNDRED THOUSAND ONE HUNDRED THIRTY SIX PESOS AND 21/100 ONLY (P 400,136.21)** by the Supplier for the execution and completion of such works and the remedying of any defects therein.

**WHEREAS**, the following documents submitted by the **NEECO II - AREA 2** shall form part of this Contract of Agreement.

- a) Contract Agreement;
- b) Bill Details;
- c) A Certification that the supplier can provide and install transformer at a reasonable cost and for which no substitute can be obtained;

NOW, THEREFORE, for and in consideration of the premises and of the terms and conditions hereinafter set forth, the parties hereto hereby agree as follows:

The **PROCURING ENTITY** hereby covenants to pay the **SUPPLIER** in consideration of the execution and completion of the delivery of **FOUR HUNDRED THOUSAND ONE HUNDRED THIRTY SIX PESOS AND 21/100 ONLY (P 400,136.21)** and the remedying of defects wherein, the contract price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

This Agreement shall take effect upon receipt by the **SUPPLIER** of **Notice to Proceed** from the Procuring Entity and shall remain in force until all obligations of both parties as contained in this contract have been fully complied with.


**TIME OF COMPLETION:** the work stipulated in this contract shall be delivered and ready for use not later than thirty (30) calendar days in accordance on this agreement.
