

Contract Agreement

THIS AGREEMENT made this 8th day of November, 2022 between Municipal Government of Gabaldon, Nueva Ecija of the Philippines represented by **Municipal Mayor Atty. Jobby P. Emata** (hereinafter called "the Entity") of the one part and **JGRAM ENTERPRISES** of Fausta Subdivision, Brgy. Mabolo, City of Malolos, Bulacan, represented by **Jose Carlo Kliatchko**, authorized representative (hereinafter called "the Supplier") of the other part:


WHEREAS the Entity requested a bid for certain **PURCHASE OF WOODEN/ARM CHAIR INTENDED FOR THE MUNICIPALITY OF GABALDON** and has accepted a quotation from the Supplier for the supply of those goods in the sum of **NINE HUNDRED NINETY THOUSAND PESOS ONLY (P 990,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Quotation Form and the Price Schedule submitted by the Supplier;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Bidder as hereinafter mentioned, the Bidder hereby covenants with the Entity to provide the equipment and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. The goods stipulated in this contract shall be delivered & ready to use not later than 30 days in accordance w/ provisions of revised IRR RA No. 9184.
