

Contract Agreement Form

THIS AGREEMENT made this **25th** day of **August, 2022** between Municipal Government of Gabaldon, Nueva Ecija of the Philippines represented by Municipal Mayor **Atty. Jobby P. Emata** (hereinafter called "the Entity") of the one part and **OROGEM'S TECH. MARKETING CORPORATION** represented by their Authorized Representative **Mr. Mark Anthony Rubio** of **24th street Kapitan Pepe Subd. San Josef Sur, Cabanatuan City** (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity requested a quotation for certain **Purchase of Projector and other Office Equipment use in various office** and has accepted a quotation by the Supplier for the supply of those goods in the sum **One Hundred Forty-Two Thousand One Hundred Forty Five Pesos Only (Php 142,145.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) The Quotation Form and the Price Schedule submitted by the Supplier;
 - (b) The Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. The goods stipulated in this contract shall be delivered and ready for use not later than ten (10) calendar days in accordance with provisions of revised IRR RA No. 9184.
